## Purpose

The Pittsfield School District operates a Title I schoolwide program based on a current poverty rate of approximately 43%, exceeding the eligibility threshold under the Elementary and Secondary Education Act. This level of poverty reflects a significant concentration of students at risk of not meeting State academic standards.

The schoolwide model allows the District to provide comprehensive, integrated supports to all students while prioritizing those with the greatest need. Key needs addressed include academic gaps in literacy and mathematics, foundational skill deficits, attendance challenges, and social-emotional barriers associated with poverty.

The District conducts an annual needs assessment using multiple data sources, including NH SAS, NWEA, DIBELS, competency-based performance data, MTSS progress monitoring, attendance, behavioral data, and poverty indicators (Free/Reduced-Price Lunch and Direct Certification), along with staff and stakeholder input. These data are reviewed regularly to guide instructional decisions, interventions, and resource allocation. With a poverty rate of 43%, the schoolwide program remains both eligible and necessary to ensure equitable access to high-quality instruction and supports for all students.

2. Describe the Schoolwide Program to improve the educational outcomes for eligible students.

The Pittsfield School District implements a comprehensive Title I schoolwide program designed to improve educational outcomes for all students by strengthening core instruction, providing targeted interventions, and addressing academic and non-academic barriers to learning.

The District uses a data-driven, multi-tiered system of supports (MTSS) to identify student needs and deliver timely interventions. Universal screening tools such as NH SAS, NWEA, and DIBELS are used to identify students at risk, and progress monitoring is conducted regularly to adjust instruction and supports.

At the elementary level, the WIN (What I Need) program provides structured, flexible intervention blocks where students receive targeted instruction in reading and mathematics based on individual skill deficits. Title I teachers deliver support through both push-in and pull-out models, working alongside classroom teachers to reinforce core instruction and provide intensive small group or individualized support.

At the middle and high school levels, students are provided with dedicated time during the school day for academic support, as well as access to competency and credit recovery programs to ensure progress toward graduation. Additional academic assistance is available through after-school and summer programming, extending learning time and reinforcing key skills.

The District integrates academic, behavioral, and social-emotional supports by implementing restorative practices, Responsive Classroom strategies, and school-based counseling services. These supports help reduce barriers to learning, improve student engagement, and promote a positive school climate.

Instructional staff engage in ongoing collaboration and professional development focused on curriculum implementation, data use, and effective instructional practices. This ensures consistent, high-quality instruction across grade levels and content areas.

Through the coordination of Title I, IDEA, and other local resources, the District provides a cohesive and inclusive educational program that supports all learners, with particular attention to students most at risk of not meeting State academic standards.

3. Describe the intended goal(s) and outcome(s) of this year's Schoolwide Plan.

The Pittsfield School District's Schoolwide Plan is designed to improve overall student achievement and ensure that all students, particularly those most at risk, meet the State's challenging academic standards in alignment with the Elementary and Secondary Education Act.

Goals:

- Increase student proficiency and growth in literacy and mathematics across all grade levels
- Reduce the number of students performing below grade-level expectations
- Improve student engagement and attendance, including reducing chronic absenteeism
- Strengthen social-emotional skills and positive student behavior to support learning
- Ensure equitable access to effective instruction and targeted interventions for all students

Intended Outcomes:

- Measurable increases in student performance on NH SAS and local benchmark assessments (e.g., NWEA, DIBELS)
- Increased percentage of students meeting or exceeding grade-level competencies
- Demonstrated student growth through progress monitoring within MTSS interventions
- Reduction in chronic absenteeism rates and improved daily attendance
- Decrease in behavioral incidents requiring removal from instruction
- Increased student participation in intervention, enrichment, and extended learning opportunities

Progress toward these outcomes will be monitored throughout the year using multiple data sources, and instructional practices and supports will be adjusted as needed to ensure continuous improvement.

4. Describe the plan to evaluate the Schoolwide Plan. Include the data to be collected and how the effectiveness of the plan will be determined.

The Pittsfield School District will evaluate the effectiveness of its Schoolwide Program through an ongoing, data-driven review process aligned with the requirements of the Elementary and Secondary Education Act. Evaluation will occur throughout the year and as part of the annual Title I needs assessment and plan review.

Data to be Collected:

- State assessment data (NH SAS) to measure proficiency and growth
- Local benchmark and diagnostic assessments, including NWEA and DIBELS
- Competency-based performance data and course completion rates
- MTSS progress monitoring data for students receiving interventions
- Attendance and chronic absenteeism data
- Behavioral data, including discipline incidents and intervention outcomes
- Demographic and poverty data (Free/Reduced-Price Lunch and Direct Certification)
- Program participation data, including intervention, after-school, and summer programs
- Stakeholder feedback from staff, families, and students

Evaluation Process:

District and school leadership teams meet regularly to review data, identify trends, and assess the effectiveness of instructional strategies, interventions, and supports. Data are disaggregated to ensure that the needs of all student subgroups are addressed. Progress monitoring occurs throughout the year within the MTSS framework to allow for timely adjustments to instruction and intervention.

Determining Effectiveness:

- The Schoolwide Program will be considered effective based on:
  - Increased student proficiency and growth on state and local assessments
  - Improved competency attainment and course completion rates
  - Positive trends in attendance and reductions in chronic absenteeism
  - Decreases in behavioral incidents that remove students from instruction
  - Evidence of student growth for those receiving targeted interventions
  - Increased engagement and participation in academic supports

Findings from this evaluation process will be used to revise the Schoolwide Plan annually, ensuring continuous improvement and alignment with identified student needs.
